PRESENTATION: Barton and Loguidice Engineers explained the Milton Ave/Bridge Street Project. The Project Manager conveyed the plans from Bridge Street to Milton Ave which will have a 16 foot promenade. Bridge Street will be milled over with new trees and street lighting. There will be underground electrical utilities. Barrett Paving is the lead contractor for the project. The streets will be paved from Bridge Street to Milton Ave as well as Cogswell Ave to the city line. Some sidewalks will be rebuilt during this process. The firm will be open on Mondays for any inquiries.

PUBLIC HEARINGS: Housing and Urban Community Development Funding
John Fall Sr motioned and Thomas Tarolli seconded to open the public hearing. Discussion on the 5 year
consolidated plan is as follows: 1. Gertrude Park, Spray Park 2. Boyd Ave Park improvements 3.Gertrude Park
Pool Bath House Improvements 4.Lower Gertrude Park improvements 5.Upper Gertrude Park outdoor
kitchen. Questions were answered by the board of trustees. John Cregg motioned and Thomas Tarolli
seconded to close the public hearing.

COMMITTEE REPORTS:

Administrative Mayor Ronald Benedetti responded: None at this time.

Legal Kevin Gilligan, Village Lawyer responded: It is on the agenda.

Treasurer Cheryl Visconti, Acting Treasurer responded: The budget is complete. The Budget meeting is scheduled for April 18th at 6pm in the Geddes Court Room.

Police Allen Wood, Police Chief - reported 866 service calls for February 2017. The department had 43 follow-ups, 12 felonies, 49 misdemeanors, 130 Vehicle and Traffic, 4 DWI, 0 juvenile, 151 parking tickets, 11 accidents and 0 stolen vehicles.

Electric Joe Hawksby, Electric Superintendent reported that they met with Barton and Luguidice. After the project is complete the underground electrical will be turned over to Solvay Electric. Gertrude Ave poles are completed. Upgrades for the orange parking lot work for the DOT will take place over a two year span. Bridge street streetscape project will begin March 27th.

DPW/Highway Mark Cazzolli, Highway Superintendent responded: Now that the weather has finally broke we can look forward to our Spring Projects. The rebuild of the Pool Retaining Wall is slated for the start in April. We have an estimated count of 23 storm drains as of now, more I'm sure to come. You will see our Dept. out this coming Monday washing down our sidewalks and getting sweeper out following behind the sidewalk crew. Our plow trucks delivery date is this coming week, the reason for such a long delay is due to when we approved the purchase and how many they added at Viking prior to our committee. We are also prepping our Summer equipment such as mowers, tractors, etc. It's just 3 ½ weeks before Little League will be wanting to sue the fields for practice. Lastly, this April 21st and 22nd, Fri and Sat is the annual Earth Day Cleanup which again this year we will all meet at the DPW on Saturday and go out in groups cleaning various areas.

Library Dan Golden, Library Director Dan offered Best Wishes to Ms. Gail Tarolli on her retirement. Dan also thanked Public Works for keeping the Library in good shape during a tough winter season. These are the upcoming programs for March and April: We have a new display in the display case by Kiwanis International. Rotating every three months.Luncheon and Networking Mixer for Small Business. Thursday, March 30, 12pm-2pm. Fridays starting April 14, at 9:30AM, a group called the Above 40 networking group will meet at the Library. This will be a regular meeting of professionals over 40 seeking guidance, job search, and career exploration. The Annual Easter Egg Hunt and Party will take place Saturday April 15 at 1pm During the summer, alongside the Summer Reading Program, the Library is also preparing an international concert series. As always, the Library welcomes suggestions from the public.
