Bridge NY grant still in process. Fox terrifying the village is being taken care of. John Cregg - compliment by Kim Richardardson a resident of the village for assistance during storm. Tree had fallen and the DPW took care of it. Neighborhood watch picnic coming up on June 11th, 6-8 at the pavilion. Everyone is invited to attend.

Treasurer	Cheryl Visconti, Treasurer reported filed NYS tax cap and certified, NYS
	constitutional tax limit. Budget modifications - 200k being taken out of fund
	balance for police retro. Would like to take the whole 350k out of surplus.
	Trustee Cregg agrees with using the surplus to not strain this year's budget.
	Trustee Bellotti respectfully disagrees. We only need 200k. Why take the
	money out then put it back in. Just take out the 200k we need. Cheryl Visconti,
	this year's budget it in extreme stress and is very close. The decision needs to
	be made now because we are at year end. Trustee Tarolli, how is Feher Rubbish
	going out effect our budget? A increase will occur using Superior Waste Removal. We currently owe Feher money but they do not owe us. Cheryl
	Visconti would like to amend the budget modification resolution to use the 350k
	out of surplus. John McPeak, resident questioned, what is the additional 150K
	for? You had modified the budget before for 181K so why would you have to do
	this now. Trustee Bellotti stated that If the checks have been cut for the police
	already, you cannot take it out again, it is illegal. Kevin Gilligan, Village Attorney
	assured that this is not illegal. Trustee Cregg interjected and agrees will using
	the 350k so the budget is not stressed and we have enough money to pay the
	bills. If the funds are not used the money goes back into the fund balance. John
	McPeak agrees with Trustee Bellotti and he has a point. You have already
	modified the budget by the tune of 181K. In the next 8 days, 150K will be for
	the highway and sidewalk work. John McPeak, asked how is highway spending
	money they do not have. Trustee Bellotti, are there any outstanding bills for the
	highway that total 180K? Visconti, there could very well be, I have not seen all
	the bills. Mayor Baichi stressed that we need the money to pay the bills. The money is identified and for village functions. If we prepare to have the money
	for the expenses and the remaining money can go into the fund balance.
	Visconti, notified the public of a new feature for electric billing, eBills.
Police	Allen Wood, Police Chief reported 1113 service calls for April 2018. The
	department had 22 follow-ups, 3 felony, 40 misdemeanors, 125 Vehicle
	and Traffic, 1 DWI, no juvenile, 240 parking tickets, 6 accidents and no
	stolen vehicles. Buckle Up New York 5/21 through 6/3. John Maestri, resident
	asked the Chiefs opinion on resolution #13. Trustee fall explained they have 1
	year to change retirement and pass a resolution and sponsored by legislation
	and pass a home rule bill. We have no idea the cost. Why pass the resolution at
	all?, Chief Wood. Other suggestions came from the crowd. Cheryl Visconti
	confirmed that no cost is available. Once a bill is passed, the amount will be
Electric	available. Mayor Baichi will table the resolution when we get to it. Joe Hawksby, Electric Superintendent - reported an update on the Bridge
Electric	Street/Milton Ave Project: walkthrough with line crew, HMT and Fdr.
	routes changed to accommodate loads. 5 KV. transformers to be located and
	cutout added if one does not exist. Tree trimming is being done when
	necessary and mostly because of wind storms. New Fdr. Maps and survey after
	Bridge Street is completed. The Orange parking lot is complete.
DPW/Highway	Richard Penhall, DPW Superintendent reported that this is my 7th day on the
	job and introduced his staff including Paul Hoffman, Zac, Chris and Sandy. We
	have been working on cleaning up parks and benches repainted on school
	road. Been working on the swimming pool and surrounding area. Summer
	help is working away. Three sewer digs this month, one camera and two
	rooter jobs. Moved books from the library over to the fire station. Cleaned up
	leaves and branches and completed high grass work orders. Trash situation at 304 Caroline that has been resolved. Follow up inspection from PESC and
	everything has been corrected. DEC has been in to make an inspection. Tar
	work this week and a tree down on school road that has been taken care of.
	Also, guard rail on school road being attended to. Continue to mow lawns
	daily. Thanks to everyone for their help in the transition to the new position.
Library	Dan Golden, Library Director - began by thanking the staff of Public Works for
	their hard work on behalf of the Friends Book sale. Dan also thanked the
	Friends and Solvay-Geddes Rotary for having spent long hours guaranteeing the
	success of the Sale. Proceeds from the book and bake
	sales totaled just under \$2,100, higher than last year's figure of \$1,862.

	According to Dan, these are the upcoming programs for the 2018 Summer
	Reading Program: MOST Science Show-Wednesday, July 11 at 10:00 a.m. The
	MOST Summer Library Program will bring a 45-minute interactive demonstration. Superhero Costume Party, Friday, July 13, 2 p.m. Party in

	Moreland the Magician-Wednesday July 25 at 10:00 a.m. Moreland the
	Magician will use a wide variety of magic tricks to celebrate the fun of reading.
	Dan the Snakeman-Thursday, August 2nd at 10 a.m. Dan Chase, the 'Snakeman,'
	will present live reptiles to teach about wildlife and the environment. Our next
	Report to the Village Trustees will provide more information on our upcoming
	Summer Reading Program, stay tuned. As always, the Library welcomes
	suggestions from the public.

	for trash complaints, 32 grass violations. Vacant homes and landlords
	have been contacted. Immediate action must been taken. We don't go by
	facebook, we go by the codes book! Next meeting is tomorrow the 23rd and
	discuss convenient stores/moratorium and potential extension six more
	months.
Stormwater	Mark Malley - addressed resolutions on the agenda concerning stormwater.
Celebrations	Mary Bosco - received funding today for event. Donations are continuing to
	come in. Trustee Tarolli asked about how many tents are going to be included
	at the event. Mary stated that right now we have three and vendors like craft
	providers will have their own. The Bands will play on a stage and we are trying
	to locate one. The City and the Fair no longer have one available. The City will
	not rent out to a facility not in the city. Also addressed the bathroom situation.
	Trustee Tarolli would not like the public to have access to the bathrooms at the field because they will get destroyed. Mayor Baichi thought it would be ok to
	use the bathrooms that are there rather than rent port-a-potties. These
	bathrooms must be handicapped accessible. All the entities in the village have
	been very supportive. Fire, Electric, Highway and Police are going to have
	demonstrations at the event. The event is on August 11th and it's all about
	community the Mayor stressed. Trustee Bellotti is concerned about the cost of
	over time from the workers needed. Mayor Baichi stated that the village will
	handle the labor costs.
Buildings	John Fall Sr - reported that the committee has been meeting for last 3-4 months
	and has come up with a potential location for the village hall. The suggestion
	was made to add the police department with the village hall. We are going to
	try it both ways and compare the cost. Bill Freitag is going to come in and go
	over the finances and the options for the village. We did look at other facilities
	and the church building is going to cost too much to rehabilitate. 500K to
	renovate the current village hall and at the end of the day you still have an old
	building with bad electric. We are looking at a site on Milton Ave across from
	the gazebo that the village owns. It is about an acre of land. It is in the design
	phase. The next meeting is on June 12th at 5:30pm. Chuck Orr, resident and
	employee questioned how the electric funds will be used for the new village hall. Dawn Decarlo, resident suggested using the funding for police and
	programs for the children rather than for a new village hall.
