CORRESPONDENCE: Mayor Benedetti introduced William McVicker as our new third Ward Trustee replacing Harry DeCarlo who resigned as trustee. Mayor received a letter of appreciation for his support and visit at John's Auto Fall Car Care Clinic.

ONS: Christine Rodgers of 205 Montrose Ave stated the flooding issues and would like the storm drains to continued being cleaned out during rain storms. Mark Cazzolli, Superintendent of the Highway Department will have his workers clean out the drains. She also questioned the comments made on social media from the fire department. The Mayor will keep on top of the situations with the Highway Department to keep the drains cleaned out.

Joe Fragnito reported on two studies on consolidation in the county being done, recommendation to have a city/county type merger, questioned the residential rate changes on energy and delivery charges. He also questions why we need electric commissioners that are all engineers, there should be an electric commissioner with a business or an accounting background.

John Nozynski objected to the minutes being approved by the Board of Trustees, questioned why the Zoning and Planning Board of Appeals are not certified each year, what was being done with the \$5 million grant that was never mentioned to the public, there is no deed for the St Cecilia school property and asking for the written request for a recall vote for the Mayor.

Paul Nozynski exercised his right for the First Amendment. He appreciates the Board for their work. Dr Nozynski has the right of Freedom of Speech and no one can deny him his First Amendment rights.

Michael Niedzialek commented on the owner of 303 Stanton Ave according to Onondaga

DPW/Highway Mark Cazzolli, Highway Superintendent reported that due to good weather, more projects were achieved than anticipated; sidewalk work and infrastructure repairs. Highway equipment is ready for snow with manpower eager to go. The highway has hired in the past month, three new employees and reported the gentlemen are working out well. main objective is mowing. The park season has come to an end and will be brush and leave pickup with added street sweeping.
