Police Allen Wood, Police Chief Reported 1023 service calls for August 2018. The

department had 41 follow-ups, 14 felonies, 60 misdemeanors, 137 Vehicle and Traffic, 2 DWI, no juvenile, 102 parking tickets, 9 accidents and no stolen

vehicles. An incident involving a stolen vehicle was addressed.

Electric John Kurtz, Asst. Electric Superintendent Reported three pole installation and

transfers have been completed on Gillis Ave. Continued installation of cut outs on 5 KV. Transformers. Working on the installation of the Electric Car Charger at the Library. The distribution and street light projects on Milton Ave and Bridge Street are complete. There is now a legal process for Solvay to take ownership of these facilities. The wind storm on Friday, September 21st caused several calls during the day that turned out to be all communication cables. Trustee Tarolli asked about rotary flags for light poles that can be put up on Milton

Avenue.

DPW/Highway

Richard Penhall, DPW Superintendent Discussed Library work with forms being made for concrete. Projects working with the Electric Department including the new gutter system. Boyd Park lighting project with assistance from the DPW. Rentals have been active this year. Cleaning after demolition in the Charles Avenue area. Gertrude Park is continuing to be working on. Contractors are wrapping up the plumbing and other construction. An order has been put in for 400 tons of salt to prepare for the plowing season. The sign machine has been set up and the pool is not closed for the season. Recently the highway commission met and discussed the packer truck. Larry Mazinski has been working on the equipment and getting it ready for winter. We have completed 216 pick-ups and 10 sewer calls throughout the month.

Library

Dan Golden, Library Director Reported that the Solvay Public Library has been awarded a \$10,000 grant from the NYS Dept of Education that was facilitated by the Office of State Assemblyman Bill Magnarelli. Funds from this grant will allow us to acquire a new set of security cameras for the perimeter of our building and six new public Internet computers. We are planning to digitize the Solvay Process Room collection, and to provide the contents online to our patrons, thereby lessening the need to handle archival documents directly. To accomplish that goal, we might need someone who can spend the hundreds of hours necessary to digitize all these materials. We are starting a new program, Welcome Wednesdays-Every Wednesday at 4p.m. This is a Weekly gettogether, crafts and events for teens and tweens. We now provide two story times per week: Tuesdays at 10:15am, and Saturdays at 10am. Previously, story times were only once a week. This is in response to greater demand for Children's programs. Here are some upcoming programs: Maria DeSantis Band and Orchestra-Saturday, October 27, 2 p.m. A musical performance of old and new hits by the Maria DeSantis Band and Orchestra. Basics of the Job Search-Monday October 29, 4 p.m. A review of the fundamentals of designing a resume, finding references and filling out applications. Holiday Open House-Sunday, December 9, 2 p.m. The Library Board and the Friends of the Solvay Public Library invite you to our annual Holiday Open House.
