CORRESPONDENCE: Mayor Baichi noted that guests from the school are here tonight. They have studied Roberts Rule of Order. We have treats and refreshments for them tonight. We encourage them to listen and ask questions. Boyd Ave Park looks great with the new lighting and other additions. The Electric Charging station is being completed. Thank you to Trustee Fougnier and the Electric Commission for their assistance. The Fire Department Open house was a great event. The Mayor Encouraged to attend the next Mayors Association Meeting in November. The last meeting this month was informative with John Katko as the guest speaker. We discussed potential grant funding for police surveillance and vehicles. The Mayor stated that it has been most productive month as a village board. Trustee Fougnier discussed a couple of letters that he received. One addressed Electric Billing issues and how to resolve these issues. We are allowing people to leave town and not pay their electric bill. If they skip town the bill should go to the home owner. Collections are going well but we need to go after the landlord. The Second letter was regarding the Lakeland area and the comprehensive plan. A posting on Facebook regarding attendance from the meeting was addressed. We had a good turnout for this meeting. About an hour of question and answer session was productive. What are we going to do as far as access to the lake was brought up. The direction for the next 10-15 years was discussed as well.

Police

Allen Wood, Police Chief – Month of September we had 1097 calls for service. This included 38 follow ups, 7 felony arrests, 70 misdemeanors, 135 traffic tickets, 2 DWI arrests, 3 juvenile arrests, 139 parking tickets, 10 accidents and 1 stolen vehicle. The Mayor stated that we are looking into turning the fleet into all SUV's. The benefit of leasing vs buying police vehicles is being looked into. This Saturday, Coffee with the Cops will take place. Dunkin Donuts is donating coffee and donuts. We have glow sticks for the children. It will take place at the Woods road pavilion. All are encouraged to attend.

Electric

John Kurtz, Asst. Electric Superintendent – The FirstLight Fiber on Long Branch Road is about 90% complete. The new holiday decoration brackets have been installed on all new street lights on poles on Milton Ave. Boyd Ave Park lighting project is complete. Trustee Tarolli asked if the lights are on a timer and they are on a photo cell. Electric car charger completed at Library. Still investigation cable fault under 695 ties between Lakeland substation and Mathews Ave Substation. Mayor Baichi noted that he was down at Electric and did a walk through. Space near building could be used to build four bays. Ads spaces and gets us by for the next 10-15 years.

DPW/Highway

Mayor Baichi – Noted that Mr. Penhall had a family emergency. Actively taking care of brush pick up to finish out the season and ample amount of salt has been purchased. We will make sure the roads are black this year. We are also looking into bobcats to get rid of snow on the sidewalks in the Milton Avenue area. The Village Clerk wrote to Ryan McMahon for assistance with potential grant funding. We did request two of them. Overall the village is in great shape. **Dan Golden, Library Director -** We are in the process of digitizing the collection of the Solvay Process Room. Our goal is to provide the contents online to our patrons. To accomplish that goal, we might need someone who can spend the

hundreds of hours necessary to digitize all these materials. We could still use one or two more volunteers.
