#### **CORRESPONDENCE:**

- New Wards/Election discussion A referendum would have to be done and it would not take effect until after the 2019 election. This would be the result of a local law that must be voted on by the board. At large elections would improve candidate base while maintain representation in all wards. A more detailed discussion will take place at our administrative meeting in May.
