department. The broken pole on 12-11-19 was caused by a sleeve splice to fail on the Lakeland Substation. This prevented us from isolating the broken pole and picking up most customers. Work has begun on the retaining wall project at 507 Charles Ave. The water heater pilot program will start sometime in January for anyone interested. We will
