Electric John Kurtz, Asst Electric Superintendent – Completing yearly

inspections of bucket trucks and diggers by vendors. Replaced two poles in different locations due to rotting found while performing EV tests. Continue yearly EV testing, 20% complete. Working on a new answering service and an updated phone vendor. Will need to do some

tree trimming in the next couple of months. Will need to start

residential meter testing soon, per PSC order.

DPW/Highway Charles Orr Jr, DPW Superintendent – Discussed several topics

including the 347 bulk pick-ups, mattresses, \$3600 in tipping fees, 15 sewer calls, averaging \$900 for brush pick-ups, road repairs, street signs, cleaning and disinfecting the buildings. The brush truck purchase was discussed by the village board. A debate occurred on how to purchase

the truck and the current need.

Library Dan Golden, Library Director - The Solvay Public Library is still offering

Library Takeout services. Residents can request materials by placing holds online with their library card number and personal identification number. Until Labor Day, our operating hours will be: 9am to 8pm

Monday-Wednesday, 9am to 5pm Thursday and Friday, and 9am to 1pm Saturday. We are still limited to curbside pickup only. Fortunately, business has been brisk and we continue to be very busy with pickup orders averaging 15-20 takeout's per hour, as well as other deliveries and requests. We are also researching and answering reference questions, continuing to work on the digitization project, offering virtual programs and reorganizing large areas of the collection and storage areas. In the fall season, we are planning to develop and expand our outreach to local schools. Although the building is not yet open to the public, we are still able to provide public programs. On July 9, we presented Moreland the Magician and on July 20, we presented the Zoo to You program as virtual events on Zoom for lively audiences of eleven and five young people respectively. In the coming weeks, we have scheduled more virtual programs that will appear on our website and on our Facebook page. The first will be our weekly story times with Library Trustee Rosemarie Novembrini. Also, on Thursday, August 13th at 10AM, the Museum of Science and Technology will offer a program on unique science experiments for young people.

Violations include bed bugs, damaged pool fence, missing attic window, collapsing retaining wall, and other general property maintenance issues. Posted three apartments at two properties Unfit for Occupancy due to lack of electrical service. One apartment remains posted. Posted one structure Unsafe to Occupy due to fire damage. Structure remains posted. Posted one structure unsafe due to vehicle damage. Structural repairs are completed.
