State Superfund Site Reclassification Notice Class 3 to Class 4

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the attached map, has been reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

- Remedial actions have been implemented at the site and remaining contamination in the landfill waste material and in groundwater will be addressed through site management as follows:
 - A landfill cap, comprised of a liner, drainage system, and clean vegetated cover, was constructed in accordance with Part 373 landfill closure requirements. The cap is maintained and inspected annually in accordance with a Site Management Plan.
 - Groundwater use restrictions were placed to prohibit the use of on-site groundwater without proper treatment.
 - Monitoring of site groundwater wells is completed routinely in accordance with a Site Management Plan.
 - Land use is restricted to commercial and industrial use.
