Police Derek Osbeck, Chief – 1257 calls for the month, up 500 from last year.

Calls include 6 felonies and 39 misdemeanors, 3 DWI arrest and 239 parking tickets issued. Various calls included assault, rape, arson, and harassment. A grant has been approved for two new Chevrolet Tahoe's

for \$197,000.

Electric William McVicker, Trustee – Described the issues near Western Ranch

with pole down that contained three transformers.

DPW/Highway John Fall Sr, Deputy Mayor – Report given during Trustee Reports.

Library Brian Rowlands, Library Manager – The new HVAC system has been

installed. This will be reimbursed by the IEEP. Staffing is at a good level at this point. Highlights to summer programs were given including

summer reading and Comic-Con event.

Codes Mark Lepetich, Code Enforcer – Several new permits and violations for

the month. A housing updated on Charles Ave was given. Several updates are still needed for the codes book. The new Energy survey is

complete at the village hall. Grant funding will be available.

- A new village resident moved here in January and has been getting involved in the community including parks program at Boyd Ave Park. Crime is occurring including a young teenager being assaulted. More supervision is needed at the park. The possibility of having more activities for teenagers may help the problem.
- Dan DeCarlo has become part of the community and like the north side, everyone looks out for everyone. Having an issue with drainage and expressed discontent with DPW Superintendent.
- Trustee Worrall spoke on behalf of resident regarding dirt pile at DPW and when paving will happen on Charles Ave.
- Trustee Miczan spoke on behalf of resident looking for update on drainage issue on Oakridge and Boulder.
- Trustee Wheatley spoke on behalf of resident regarding parks program at Boyd Ave.
