1. **165-44 Business certificate use**

Mark Lepetech, Code Enforcer explained the local law and how it will get rid of background checks. This will also include judicial recommendation. Trustee Miczan asked if local law will limit the number of the same type of businesses. Attorney Herkala explained the law further and that a three-person committee will make final recommendation.
