Sealed bids for the Collection and Disposal of All Refuse, Rubbish, Garbage, and Recyclables for the Village of Solvay, will be received by the Village Board, Village of Solvay, Onondaga County, New York at the Village Town Hall, 1100 Woods Road, Solvay, New York 13209, until **11:00 A.M.**, Local Time, **March 20, 2026**, and there at said Village Hall, at said time, publicly opened and read aloud.

This Contract includes all the labor, equipment, and materials necessary for the Collection and Disposal of All Refuse, Rubbish, Garbage, and Recyclables in the Village of Solvay, beginning June 01, 2026. A reduced copy of the district map is included with the Contract Documents and shows the locations of the approximately 2659 homes to be served, with 1 Highway Garage Dumpster, One Transfer Station Dumpster, 2 Totes at the Village Hall, 2 Totes and 1 Dumpster at the Mountain Top Fire Station.

The boundary description and a full-sized map of the district are on file in the office of the Village Clerk and may be examined by all persons interested therein during regular business hours. Any Contractor bidding to perform services under this proposal shall be solely responsible for determination of the volumes and tonnages involved.
